Dignity Act for Elementary Students

New York State Lawmakers believe it is essential to treat everyone with respect and civility at all times. They have passed a law, called "The Dignity Act," which is meant to help all students know how they should treat one another, both in school and in the community, and what kind of behaviors will not be allowed.

**The Dignity Act States that NO student shall be subjected to harassment or discrimination by employees or students on school property or at a school function based on their actual or perceived race, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender, or sex.**

Bullying *usually* occurs when someone uses power over another person and it *usually* occurs repeatedly. There are different types of bullying: Verbal Bullying-can include name calling & teasing. Physical Bullying-can include hitting, kicking, & pushing. Social Bullying-can include exclusion & rumor spreading. Cyber bullying-is when people show any kind of bullying behavior using technology to harass or intimidate (computer, cell phones, iPods, etc.)

We hope that everyone will follow our Students' Responsibilities. However, if someone forgets, we have consequences from our Code of Conduct in place. Our building principals and elementary social workers are the Dignity Act Coordinators and they will work together in order to make sure everyone feels safe and comfortable and that our students are caring citizens.

## Student Responsibilities

1. Listen to and respect all adults in the school community.
2. Listen carefully to all directions.
3. Walk quietly through the halls.
4. Tell the truth at all times.
5. Care about your classmate's feelings.
6. Respect other students and their property.
7. Be kind, polite and considerate of others.
8. Practice good sportsmanship.
9. Invite others to play with you and include other children if they are alone.
10. Use appropriate words to solve problems.
11. Use a quiet, inside voice.
12. Get permission from an adult to leave an area.

Students are expected to follow these expectations in areas such as classrooms, hallways, cafeteria, playground, sporting events, offices, buses, field trips, and/or afterschool activities.

We fully expect that students will respect people, property, and school rules. For those who do not follow the rules, consequences will result.

## The following are examples of consequences that may be given:

Verbal warning

Written warning

Parent contact

Referral to our School Social Worker and/or Psychologist

Detention or removal from an activity

Restitution

Suspension from transportation

Suspension from extracurricular activities

In-school suspension

Student removal from class

Out-of-school suspension
