- G. **BE IT RESOLVED** that the Board of Education accepts the **Extra Classroom Activity Funds**Report for the month of January 2015.
- H. **BE IT RESOLVED** that the Board of Education approves the contract with **Serene Home Nursing Agency** who will be providing sub-nursing services if needed to the East Islip

  School District in the 2014-15 school year. The fee for these services is \$50 per hour on
  an as-needed basis. This expense will be paid from the general fund.
- I. **BE IT RESOLVED** that the Board of Education approves the **Health Services Contract with Sayville Public Schools** for the 2014-15 school year. This contract is for health services provided to one of our students who attend West Sayville Christian School located in the Sayville School District. The cost is \$1,025.46 and will be paid from the general fund.
- J. **BE IT RESOLVED** that the Board of Education approve the **Health Services Contract with Uniondale Union Free School District** for the 2014-15 school year. This contract is for health services provided to three of our students who attend Kellenberg Memorial High School located in the Uniondale School District. The cost is \$1,846.41 and will be paid from the general fund.
- K. **BE IT RESOLVED** that the Board of Education approves the attached **Refunding Bond Resolution**. This bond was originally issued for the East Islip Union Free School District in 2007 (the "2007" Refunded Bond) in the amount of \$6,507,391. There is a potential cost savings on this bond based on the attached analysis if it is refunded. By approving the resolution to refund this bond, the district can take advantage of more favorable interest rates which would reduce its annual interest payments. There is no upfront issuance cost to refund this bond. The anticipated savings, over the remaining term, for the 2007 Refunded Bond is \$144,632. This projected savings is subject to interest rate fluctuations at the time of sale.
- L. **BE IT RESOLVED** that the Board of Education approves the **Collateral Agreement** between the East Islip School District, **HSBC Bank USA, and The Bank of New York Mellon.**
- M. **BE IT RESOLVED** that the Board of Education accepts the \$500 Neil C. Skidmore Scholarship that will be awarded to a graduating senior who has been accepted to any program of higher education, which includes a two/four year college, vocational training, BOCES, professional programs and who has demonstrated the spirit of volunteerism and humanitarianism in the community through an organized charitable, nonprofit, and/or school program.
